The following is an update to the prior notice sent 11/7/2024.

Medical Necessity Criteria for Applied Behavior Analysis

Aetna Better Health of Kentucky would like to provide information regarding medical necessity criteria for Applied Behavior Analysis (ABA) and give notice of a claims edit that will be in effect as of <u>January 1, 2025.</u>

We comply with federal and state regulations when selecting medical necessity criteria and have adopted Milliman Clinical Guidelines (MCG) as the primary criteria for medical necessity for all services except for substance use treatment services. The ASAM (American Society of Addiction Medicine) criteria is the treatment criteria for substance-related treatment.

Per the MCG BHG (Behavioral Healthcare Guideline) for Applied Behavior Analysis, ABA is appropriate in the treatment of Autism Spectrum Disorder (ASD).

- In the absence of co-occurring ASD, there is a lack of high-quality research evidence to support the use of applied behavior analysis (ABA). ABA is considered experimental, investigational, or unproven for all other non-ASD indications because of insufficient evidence in the peer-reviewed literature.
- Extensive research supports the efficacy of ABA specifically for managing behaviors and improving skills impacted by autism, making it the primary justification for requiring an ASD diagnosis for coverage.

At the time of this notice to providers, prior authorization remains waived by The Kentucky Department of Medicaid Services for behavioral health outpatient services, including ABA. To ensure alignment with MCG criteria:

 Aetna Better Health of Kentucky will require that claims submitted for ABA services reflect the medical necessity requirement that recipients of ABA services have received a diagnosis of ASD and that diagnosis should be included on claims for ABA.

• Claims submitted for ABA services without the required ASD diagnosis will be denied.

Providers may appeal denied claims per standard appeal processes.


